#### 1 Summary

An archaeological evaluation (three trial-trenches) was carried out on land at Rascasse, Sheepcotes Lane, Silver End, Essex in advance of the construction of a new residential development. The site lies on the periphery of the historical village of Silver End in the district of Braintree. Despite lying in an archaeologically-sensitive area, the only feature excavated was a post-medieval ditch in the southernmost trench on site.

#### 2 Introduction (Fig 1)

This is the report for an archaeological evaluation carried out by Colchester Archaeological Trust (CAT) on land at Rascasse, Sheepcotes Lane, Silver End, Braintree, Essex on 26th to 27th April 2023. The work was commissioned by Steve Higgon of HGN Design Ltd, on behalf of Zero Three Care Homes, and took place in advance of the construction of a new residential buildings, car park and services.

In response to consultation with Essex County Council Place Services (ECCPS), the Historic Environment Advisor stipulated that in order to establish the archaeological implications of this application, the applicant should be required to commission a scheme of archaeological investigation in accordance with the *National Planning Policy Framework* (MHCLG 2021).

All archaeological work was carried out in accordance with a *Brief for a trial trenching evaluation and excavation on land at Rascasse, Sheepcotes Lane, Silver End, Essex* written by Teresa O'Connor and detailing the required archaeological work (ECCPS 2023), and a written scheme of investigation (WSI) prepared by CAT in response to the brief and agreed with ECCPS (CAT 2023).

In addition to the brief and WSI, all fieldwork and reporting was done in accordance with *Management of Research Projects in the Historic Environment (MoRPHE)* (Historic England 2016), and with *Standards for field archaeology in the East of England* (EAA **14** and **24**). This report mirrors standards and practices contained in the Institute for Archaeologists' *Standard and guidance for archaeological field evaluation* (CIfA 2014a) and *Standard and guidance for the collection, documentation, conservation and research of archaeological materials* (CIfA 2014b).

#### 3 Archaeological background

The following archaeological background includes extracts of the ECC Brief (ECCPS 2023) and Essex Historic Environment Records (EHER) held at Essex County Council, County Hall, Chelmsford, Essex (accessed via <u>http://www.heritagegateway.org.uk)</u>.

The site is located within a large area of complex multi-period archaeological remains. Recent investigation to the north-west of the site has revealed Bronze Age and medieval settlement, and to the north-east, ongoing archaeological investigations at Bradwell Quarry have revealed multi-period archaeological evidence, most recently an enclosed Roman settlement and medieval settlement. To the south-east an enclosed Later Iron Age farmstead has been identified, with medieval and later activity, closer to Bower Hall moated site (NHER 8092).

#### 4 Aims

The aims of the archaeological evaluation were to record the extent of any surviving archaeological deposits and to assess the archaeological potential of the site to allow the ECCHEA to determine if further investigation is required.




Fig 2 Trench results.

#### 5 Results (Figs 2-4)

Three trial-trenches were machine-excavated under the supervision of a CAT archaeologist. The trench plan stated in the WSI was to have a fourth trench to the north-west of T1, however on-

site constraints inhibited the original plan and a new one was agreed with the ECCPS monitor (Fig 1). Trench 1 was extended to the north-west in order to compensate for losing T4, as well as to cover the footprint of the proposed road layout without encroaching into the contaminated zone. The other trenches were adjusted slightly due to vegetation encountered on site, but were otherwise in their intended places.

Across site modern topsoil (L1, c 0.30m thick) sealed a buried soil (L2, c 0.26m thick) which overlay natural (L3, encountered at a depth between 0.46-0.65m below current ground level). A layer of modern made ground (L4, c 0.14m thick) was observed in Trench 1 cutting into L1.

#### Trench 1

T1 was opened on a NW-SE alignment and measured 38m in length and 1.8m in width. There was an unexcavated modern pit which was encountered within the make up of the topsoil. No other archaeological contexts were encountered within trench 1.

#### Trench 2

T2 was opened on a NW-SE alignment and measured 25m in length and 1.8m in width. There were no archaeological contexts encountered within trench 2.

#### Trench 3

T3 was opened on a NE-SW alignment and measured 24.5m in length and 1.8m in width. Ditch F1 was on a NW-SE alignment and measured at c 1.17m in width and c 0.21m in depth. The feature yielded abraded post-medieval CBM within the single fill.

#### 6 Finds

Abraded fragments of post-medieval CBM from F1 were not retained for post-excavation analysis. There were no other archaeological finds from the evaluation.

#### 7 Conclusion

Despite the development area being located within a landscape high in potential for archaeological contexts, the only feature that was excavated during the work was a postmedieval ditch which likely represented an out of use field boundary (F1). The field boundary isn't represented on any ordnance survey maps meaning the ditch went out of use before the late 19th century.






Fig 3 Feature and representative sections.
