1 Summary

Archaeological monitoring was carried out at Old Riffhams, Riffhams Chase, Little Baddow, Essex during groundworks to install a new boiler plant and other works. Old Riffhams is a Grade II listed timber-framed building dating back to the mid 16th century, possibly with an earlier core. Archaeological monitoring did not reveal any significant archaeological remains. The only features uncovered were modern brick and concrete foundations associated with an old oil drum on the site.

2 Introduction

This is the report for archaeological monitoring carried out by Colchester Archaeological Trust (CAT) at Old Riffhams, Riffhams Chase, Little Baddow, Essex, from the 26th April to the 4th July 2023. Commissioned by the homeowner, groundworks took place during the installation of a new boiler plant, with associated trenching, to feed the main house, plus other works.

As the site lies within an area highlighted by the EHER as having a high potential for archaeological deposits, an archaeological condition was recommended by the Essex County Council Place Services Historic Environment Advisor (ECCHEA). This recommendation was for a programme of archaeological monitoring based on the guidance given in the *National Planning Policy Framework* (MHCLG 2021).

All archaeological work was carried out in accordance with a *Brief for archaeological monitoring* at Old Riffhams, Riffhams Chase, Little Baddow (ECCPS 2022) and a Written scheme of investigation (WSI) (CAT 2023).

In addition to the brief and WSI, all fieldwork and reporting was done in accordance with *Management of Research Projects in the Historic Environment (MoRPHE)* (Historic England 2016), and with *Standards for field archaeology in the East of England* (EAA **14** and **24**). This report mirrors standards and practices contained in the Institute for Archaeologists' *Standard and guidance for archaeological field excavation* (CIfA 2014a) and *Standard and guidance for the collection, documentation, conservation and research of archaeological materials* (CIfA 2014b).

3 Archaeological background


The following archaeological background includes extracts of the ECC brief (ECCPS 2022) and Essex Historic Environment Records (EHER) held at Essex County Council, County Hall, Chelmsford, Essex (accessed via http://www.heritagegateway.org.uk).

Old Riffhams is a Grade II listed timber-framed building (NHLE 1122037, EHER 30644). It is built on a half H-plan and is of three storeys. While the building is said to have origins in the mid 16th century, the listing entry proposes it may have an earlier core. It has 17th- and 18th-century additions, including being almost completely refaced in red brick and a parapet added. Although there have been considerable later alterations, many of the 16th, 17th and 18th century features have been preserved.

The EHER records that medieval pottery, tiles and a horseshoe were found on land at Old Riffhams in 1927. More medieval pottery was recovered in 1949 (EHER 5597).

The Geology of Britain viewer (1:50,000 scale¹) shows the bedrock geology of the site to be London clay formation (clay, silt and sand) with superficial glaciofluvial deposits (sand and gravel).

4 Aim

Archaeological monitoring was undertaken to excavate and record any archaeological deposits which were exposed by the groundworks.

5 Results (Figs 2-3)

All of the groundworks were machine-excavated and monitored by a CAT archaeologist. A full context list can be found in Appendix 1.

Two trial-pits were excavated close to the front of the building in advance of the excavation of lantern traps. This was carried out to identify the depth and configuration of the foundation associated with the front steps. The trial-pits were 0.5m square and excavated to a depth of 0.5-0.6m below current ground level (bcgl). Modern topsoil (L1, 0.3-0.4m thick) sealed a deposit of modern made-ground (L2). Modern building debris including brick, concrete and roof tile was present in L1, with mortar and tile fragments from L2 (none being retained for post-excavation analysis).

An area covering approximately 41 square metres was excavated during groundworks for the new plant room and associated trenching. Close to the house, modern topsoil L1 (c 0.25m thick) sealed made-ground L2 (c 0.11m thick) above natural L3 (identified at a depth of 0.35m bcgl). Further from the house, L1 (c 0.12m thick) sealed subsoil L4 (0.13m thick) above natural L3 (c 0.25m bcgl). Brick and concrete foundations were uncovered close to the boundary wall of the site, with both belonging to an old oil drum installation that was removed prior to groundworks beginning.

There were no archaeological finds.

7 Conclusion

Archaeological monitoring at Old Riffhams, Riffhams Chase, Little Baddow, Essex did not reveal any significant archaeological remains. The only features uncovered were modern brick and concrete foundations associated with an old oil drum on the site that was dismantled just before groundworks began.




Fig 1 Site location.




Fig 2 Trial-pits to the front of the house.




Fig 3 Ground reduction area, foundation trench and service trenches for new plant room, showing the modern brick and concrete foundations.




Fig 4 Representative sections.
